

tepeoPRO Win England v Australia Tickets - Promotion Terms

- 1. The promoter is tepeo Limited, a company incorporated in England and Wales with company number 11392873, whose registered office address is at 630 Wharfedale Road, Winnersh, Wokingham, England, RG41 5TP ("tepeo").
- 2. This offer is only valid for approved tepeoPro Authorised Resellers, who are already part of the tepeo Authorised Reseller Network or who are appointed into the Network by 31st August 2024, and is subject to the terms and conditions of the Master Reseller Agreement between tepeo and the Authorised Reseller. Unless otherwise stated, defined terms used in these terms and conditions shall have the same meanings as set out in the Master Reseller Agreement.
- 3. Both new and existing tepeoPRO Authorised Resellers will automatically receive one entry for their first organic sale only if they have not already made a sale before 1st August, into the prize draw during the Promotional Period on each Qualifying Order placed during the Promotional Period. tepeoPRO Authorised Resellers can choose to opt out of the promotion if they require.
